

## **Privacy Information by Industrie Saleri Italo S.p.A.**

Pursuant to art. 13 of Leg. Decr. no. 196/2003 and of the art. 13 of EU Regulation 679/2016, Industrie Saleri Italo S.p.A., as “Controller” of the processing, is required to provide information regarding the use of the User's Personal Data.

### **1. Types of Data collected**

Among the types of Personal Data that Industrie Saleri Italo S.p.A. collects there are: company name, first name, last name, e-mail address.

### **2. Source of Personal Data**

The collection of Personal Data is done by recording the data provided by the User himself, as Data Subject, upon registration to the REQUEST INFORMATION form of the CONTACTS section.

### **3. Purpose of the processing**

Personal Data are processed exclusively to provide feedback to requests for information made by the Data Subject via the above form.

### **4. Methods of processing Personal Data**

Personal Data is processed using computer and/or IT enables tools with logics and organizational methods strictly related to the aforementioned purpose and, in any case, in order to guarantee the security and confidentiality of the Data.

### **5. Mandatory and Optional nature of the provision of Personal Data**

Personal Data may be freely provided by the User.

Some Data requested by Industrie Saleri Italo S.p.A. are mandatory and, in the absence of their contribution, it would be impossible for Industrie Saleri Italo S.p.A. provide the service. In cases where Industrie Saleri Italo S.p.A. specifically states that some Data is not mandatory, Users are free not to communicate this Data without any consequences on the availability or the functioning of the service.

### **6. Categories of subjects to whom the data can be communicated or who can learn about it**

Personal Data may be known only by subjects responsible for responding to requests for information.

### **7. Retention Time**

The Data are processed for the time necessary to fulfill the established purpose. After that, the data will be deleted.

### **8. Rights of the Data Subject**

Finally, we inform you that the legislation on the protection of personal data confers on the Data Subject the possibility to exercise specific rights, based on the provisions of art. 7 of Leg. Decr. no. 196/2003 and from the art. 13 and the articles from 15 to 22 of EU Regulation no. 2016/679.
